### **Terms and Signatures**

1. This contract contains terms agreed by client(s) and videographer. Any changes must be in writing and signed by both parties.
2. The client(s) agree to confirm the event one month in advance and to provide the videographer with any venue changes in advance. The client agrees to be responsible for additional charges due to venue changes, if applicable. Additional charges include travel expenses.
3. The client agrees the videographer will begin the shoot and end the shoot at the times Specified in the contract.
4. The Videographer and askem studios are not liable for compromised shoots due to Circumstances beyond the videographers control. These circumstances include Uncooperative guests, lateness of clients or guests, last minute venue changes and weather conditions. Further, the videographer and askem studios will not be held liable for background items or venue lighting that has a negative effect on the quality of the video shots.
5. If askem studios is forced to cancel the event due to conditions beyond his or her control, the Company will secure a replacement Videographer if possible. If a replacement cannot be found, askem studios shall have limited liability in the form of returning all deposits.
6. In the event of equipment failure, lost or stolen equipment or video, askem studios shall have limited liability in the amount of the entire contract price.
7. The client(s) are responsible for securing any licenses or releases for the videography services at the venues.
8. The client(s) or wedding coordinator agrees to ensure the people specified in each shot are available.
9. While turnaround times are quoted at 60 - 90 days for Full Highlights there is the potential that turnaround times could vary due to Wedding Season volume and life events.
